2. How to Post Changes to Indexes:

- 2.1. Conduct an inventory of publications on hand using the index as a guide.
- 2.2. Beside each required publication place a plus sign (+) to show it is on hand, or a minus sign (-) to show it is required and not on file.
- 2.3. Requisition all publications with the minus sign.
- 2.4. Upon receipt of publications, add a vertical stroke to the appropriate minus sign (-) to make a plus sign (+) showing the publication is now in the files.
- 2.5. Upon receipt of a revised publication, annotate the date of that publication in the index.
- 2.6. Upon receipt of a change, add the change and date immediately below the basic publication.
- 2.7. Upon receipt of a new publication, insert the number, date, title of that publication in numerical order, and line out publications declared obsolete.


